- Indoor exhibit areas available: Approximately 60 – eight foot booths with six foot tables. You may opt to exhibit with or without a table. **Please limit your display to the eight foot booth space.** Multiple booths may be purchased.
- Exhibits shall be installed anytime between 8:00 a.m. and 11:30 a.m. on Wednesday, and may be removed at any time after 4:30 p.m. No other off-site exhibits or hospitality events are allowed during this time period unless pre-approved by the Vendor Exhibit Chair.
- Outdoor exhibit areas available: Ample parking lot exhibit spaces will also be available, with proper exhibit registration. This outdoor exhibit area is directly adjacent to and visible from the indoor exhibit area.

- The Meet & Greet is held in the Vendor Exhibit area. Vendors are encouraged to participate in the Meet & Greet and are not required to remove their display until after the Meet & Greet
- Co-sponsored by manufacturer representatives, contractors, consultants, and other vendors/contributors.
- Names of sponsors will be posted at the Meet & Greet and in the *Wastewatcher* publication.

The cost per exhibit booth is \$325 if received by July 1, 2021. Credit card payments are accepted on the MWOA website. Late exhibit registration, if space is available, will cost \$425 per booth. The exhibit fee entitles your organization to be listed as a co-sponsor at the Meet & Greet and in the *Wastewatcher*. Two non-transferrable luncheon tickets are included with each exhibit space. Lunch for vendors will be served at 11:30. **Conference registration and banquet tickets are not included**, but are available for purchase on the conference registration form and at the MWOA registration desk.
