Record Keeping; It IS Important!

If you need to ask the MPCA for a copy of **YOUR** records, you are in violation! Does that catch your attention? Hopefully so.





We have had many requests to get copies of records from permittees that land apply biosolids. I get it. There are things that do happen and legitimate reasons for needing a copy. For example, one city lost their records in the floods. I also get that sometimes you may take over for someone who isn't stellar in their organizational abilities and you can't find where s/he kept biosolids-related records (if they kept records). Whatever the reason for the missing records, the Permittee (the City) is in violation and could potentially receive an enforcement action. If you find yourself in a situation of missing records, it is best to call and work with either myself or your compliance staff to get copies as soon as you realize that information is missing and it is best to do so prior to an inspection rather than MPCA staff discovering it is missing. Good recording keeping is critical to being able to demonstrate compliance.

Here is a reminder of what records to keep:

Records to be kept indefinitely:

The location of land application and stockpile sites on a U.S.G.S quadrangle or soil map;

The legal descriptions of the sites;

The amount of biosolids applied for the cropping year and cumulatively in tons/acre;

The amount of metals applied for the cropping year and cumulatively in pounds/acre;

The date of biosolids application;

A signed certification statement for contacting the MPCA to see if a site has reached its cumulative pollutant loading rate;

A description of how the information to determine if a site has reached the cumulative pollutant loading rate was obtained.

Records to be kept for 5-years:

Record Keeping Continued

Concentration of analytical parameters (metals, nutrients, solids content);

A signed certification statement for meeting pathogen and vector attraction reduction requirements;

A description of how the pathogen reduction requirements are met;

A description of how the vector attraction reduction requirements are met;

Records of soil test data;

Maximum Available Nitrogen Application (MANA) rate for the crop(s) grown;

The known amount of nitrogen applied to the crops for the cropping year;

The record of the applier's certification statement (whether the preparer or a different party applies the biosolids) used to determine compliance with management practices, site restrictions and vector attraction reduction requirements (if injection or incorporation are used to meet the requirement). Preparers must keep as part of their records a description of how those requirements are met. (The certification statement that applies to management practices is number 4 on page 4 of the annual report.)

Additional information can be found in Chapter 13, starting on page 189, of the Biosolids Manual and in MN Rule 7041.1600, Record Keeping.

MWOA Scholarships

The MWOA each year sets aside funds for up to four scholarships to be given at the Annual Awards Banquet in July. Should a person be working on a masters or advanced degree – supporting documentation from the institution should be made to indicate more than fifty percent completion on the course of study).
